




Global Siteblocking OVERVIEW

Major pirate websites blocked




PROCEDURAL ROUTE








LEGAL FRAMWORK AND ISPs COOPERATION

PRINCIPLES

- No fault injunction
- RHs monitor blocked domains and submit new targets
- ISPs never asked to "police the internet"



LEGAL FRAMEWORK AND ISPs COOPERATION

UNITED KINGDOM

- Section 97A CDPA
- Case law High Court, Newzbin, October 2011
- ISPs do not oppose Siteblocking orders

No ISP opposition in court, orders executed within 7 working days

Further developments:

- Pirate Brand Orders: 123movies (July 15, 2022), Fmovies, primewire, putlocker, soap2day, solarmovie (March, 2023)
- •Blocking order issued against cyberlocker Mixdrop (2022)





LEGAL FRAMEWORK AND ISPs COOPERATION

THE NETHERLANDS

- Art. 26d. Copyright Act: 'At the request of the author, the court can order intermediaries whose services are used by third-parties to infringe on copyright, to stop providing the services that are used to infringe copyright'
- Case law –Amsterdam Court of Appeal, Brein v XS4ALL and Ziggo (2 June 2020)
- **Agreement** between RHs and ISPs (Ziggo, KPN, DFN, T-Mobile, Canal+, and members of the industry organization NLConnect agree to block pirate sites when RHs obtain a blocking order against one of the other ISPs)
- Speed: Court proceeding takes approx. 1 year
- When the blocking order is obtained against one ISP, others follow the suit.
- Enforcement: blocks implemented by ISPs after Court Order
- Technical measures: DNS blocking



LEGAL FRAMEWORK AND ISPs COOPERATION

SWEDEN



- Art 53 Copyright Act: 'The court may, on a petition from the author, a right holder, or a person issue a prohibition against those who take or aid and abet copyright infringement to prevent a continuation of that action.
- Case law Patent and Market Court, Studios vs Telia (29 June 2020)
- Agreement between RHs and ISPs re non-opposed Siteblocking application:
- RHs apply for blocking measure and communicate the draft application to ISPs, if clear ISPs do not oppose
- Court proceeding takes approx. 1 year
- Website specific blocking: blocking of new domain names within few days
- Technical measures: DNS blocking



LEGAL FRAMWORK AND COOPERATION

European Commission recommendation





- EC recognizes RHs struggle re live content piracy (technical challenges, circumvention measures, offshore hosting, 'piracy —as a service').
- EC aims at fostering collaboration between sports event organisers, holders of rights, providers of intermediary services and public authorities.
- EC points to raising awareness and voluntary cooperation between public authorities. MSs are encouraged to raise user's awareness on legal offers and raise awareness with national law enforcement authorities.
